DESCRIPTION

Fothergill Business Park comprises 8 No. Commercial Units located in a high profile location on the junction of Colley Lane and Parrett Way.

ACCOMMODATION

A brick built industrial unit with corrugated clad sheeting roof and frontage. The unit is accessed via pedestrian door to the front of the unit leading in to the offices, along with roller shutter door access in to the workshop.

The accommodation comprises open plan reception area and office, staff room and kitchen facilities and WC leading in to the workshop area, with stairs leading to first floor mezzanine area with two additional offices/ store areas.

SERVICES

Mains electricity, water and drainage are connected to the property. Telephone lines available for connection subject to BT Regulations.

RATES

SERVICE CHARGE

BUILDINGS INSURANCE
