DESCRIPTION

Unit 1 is one of the front facing units on the site, with access in to the warehouse via a new roller door on the East Elevation.

The unit benefits from plenty of office space at ground and first floor level as well as mezzanine storage although the mezzanine storage could be removed if required.

SERVICES

Mains three phase electricity, water and drainage are connected to the property. Telephone lines could be available for connection subject to BT Regulations.



EPC

The EPC rating is C66. A copy can be made available on request.

RATES

The current rateable value for Unit 1 based on the April 2023 assessment is £16,250. We estimate the rates payable to be £8,109 per annum.

SERVICE CHARGE

A service charge is payable for the proportional area of occupation to cover water, communal site electric, maintenance and repair of common areas, CCTV operation of site and any other shared costs.

The current charges for Unit 1 are £0.15 per sq. ft - subject to review annually.
